- 6.9.2. Submissions to PLANMALAYSIA and other Government Authorities

- 6.9.3.1. The SIA Consultant shall submit both GIS and Geospatial document in native format to MyHSR Corp and any other format as required MyHSR Corp upon request thereof.
- 6.9.4. **Submissions of document through Assai**
- 6.9.4.1. The SIA Consultant will be given one (1) license to access Assai for submission of all documents.
- 6.9.4.2. The SIA Consultant shall attend a session with MyHSR Corp's Document Control team to understand the submission of the document and any other necessary requirement as required.

7. DATA TO BE PROVIDED BY MYHSR CORP

7.1. Data to be provided

- 7.1.1. MyHSR Corp will make the following data available to the successful SIA Consultant upon the award of the LOA or at a date otherwise specified by MyHSR Corp. The SIA Consultant shall notify MyHSR of any discrepancy or any non-conformity of the design output with the statutory requirements contained within this information:-
- i. HSR Project timeline including the relevant interface activities;
 - ii. Term of Reference (TOR) Environmental Impact Assessment (EIA) and EIA Report;
 - iii. Traffic Impact Assessment (TIA) and Traffic Management Plan (TMP);
 - iv. Alignment in KMZ format;
 - v. Topographical data of the HSR corridor based on Lidar surveys;
 - vi. Land use data from PLANMalaysia;
 - vii. CAD Standard; and
 - viii. Communication protocols.
- 7.1.2. The SIA Consultant shall adhere to periodic reporting as required by MyHSR Corp from time to time.
