The Terms of Reference for the SIA study of the Kuala Lumpur- Singapore High Speed Rail (HSR) Project

PLANMalaysia has propose the following aspects be incorporated in the Terms of Reference document:

1. OBJECTIVE OF SIA

The overall objective of the SIA is to identify, analyse and manage the intended and unintended social consequences, both positive and negative of the HSR project and any social change processes invoked by these processes

In accordance to the Manual on Social Impact Assessment, 2017 (2nd Edition), the SIA study shall:

- i. Engage all relevant stakeholders to identify social issues, impacts and its predictions as well as strategies to manage social impacts;
- ii. Provide a detailed description and analysis of the social pre-project baseline situation as a basis for social profiling, mitigation and future monitoring
- iii. Provide an assessment based on collected baseline data and public engagements to identify both positive and negative social impacts, direct and indirectly affected parties (and especially the marginalised groups)
- iv. Determine impact predictions using effective techniques during planning stage, construction stage and operational stage
- v. Determine level of significance of impacts for effective mitigation measures.
- vi. Optimise positive impacts and mitigate negative impacts throughout the project lifetime
- vii. Develop a Social Impact Assessment (SIMP) that can effectively be implemented to mitigate negative impacts and optimise positive impacts

2. SCOPE OF SIA STUDY

1. The preparation of the SIA study should be guided by the Manual on SIA (2nd Edition) 2017 produced by PLANMalaysia (Federal Town and Country Planning Department). Accordingly, the SIA study should be organised to incorporate the various levels of an impact assessment as follows:

- Screening
- Scoping
- Baseline study
- Prediction and evaluation of impacts
- Mitigation
- Social Impact Management Plan
- 2. The given corridor of the HSR should form the basis for the SIA study and the SIMP to be developed should be at the appropriate level of detail corresponding with the scale and significance of the project that can be translated by the various states to develop further their respective SIMPs in an effective and coordinated manner
- 3. The HSR has many spatial implications at the national, regional and local level. Being a strategic project that transverse several states namely the states of Selangor, Negeri Sembilan, Melaka and Johor, thus the SIA study shall has to adhere to the spatial management plan of the National Physical Plan 3 that synchronises spatial planning at the national level.
- 4. SIA is an effective tool in implementing social policies of the government at the development project level. Therefore the SIA study shall incorporate elements of the government's social policies of inclusivity and equity in line with the aspirations of leaving no one behind from the benefits and opportunities that a development project can offer. Appropriate social outcomes and targets in line with the government's aspirations need to be appropriately incorporated in the SIA study
- 5. The methodology of the SIA study has to be comprehensive that shows clearly the types and scale of public engagements to be undertaken, appropriate techniques and models as well as expert inputs needed to effectively identify social impacts, prediction and assessment.
- 6. Determination of Zone of Influence is crucial for this study. An effective Zone of Influence will ensure an accurate analysis of social issues and impacts that influences subsequent findings. In determining Zone of Influence, data and information gathered during the baseline study and public consultation should be utilised. Spatial planning as contained in the National Physical Plan 3 should also be an integral input in identifying Zone of Influence.

- 7. The SIA study shall be based on most updated data and information that include existing land use zoning as well as any committed development that has to be verified by the various states.
- 8. The SIA study shall has to make references to other impacts assessment studies especially Environmental Impact Assessment (EIA) since findings of other impact assessment on various fields have social implications that need to be addressed in SIA. Data and information in the SIA should be consistent with other impact assessment studies.

OTHER GENERAL COMMENTS

- In the context of this SIA study, a Terms Of Reference document should define all aspects of how the consultant and the team shall conduct the study. It should define the objectives and the scope of the study, the professional/expert inputs needed for the study and outlines the responsibilities of each consultant in conducting the study. It should also include the time frame involved and costing.
- 2. The Terms of Reference for this SIA study is too bulky (414 pages). Since the TOR for SIA is different from the EIA study, it is therefore necessary at this point to include information that is only relevant. It is also not feasible to identify Zone of Influence at this stage. An effective Zone of Influence need to be determined by the consultant after thorough analysis at the scoping and baseline data stage of the study is undertaken.
- 3. TOR document need to be focussed and effective in guiding the consultant on how to conduct the SIA study. It should not pre-empt and dictate the designated consultant on determining the methodology of the study to be applied, mitigation measures and SIMP. This can be effectively done by the designated consultant at the scoping stage of the study after thorough analysis.
