Request For Information (RFI)

1. Background and Objective

The Government of Malaysia (GOM) aims to improve intercity mobility with a view to generate socio-economic development through reduced journey time, safe and seamless travel, and enhanced accessibility to our second and third-tier cities. With this aim in mind, the GOM intends to implement our first High Speed Rail line in the southern corridor of Peninsular Malaysia.

MyHSR Corporation Sdn Bhd (MyHSR Corp), a company wholly-owned by the Minister of Finance (Incorporated), has been tasked to initiate an RFI to solicit concept proposals from local and international industry players to assess their readiness and capabilities, while gathering innovative business models and supplementary revenue-stream ideas for a privately funded structure.
